#### It started with a bank in bankruptcy

Kenya is well known for its spectacular wildlife and Olympic-class distance runners, but thanks to people like Dr. James Mwangi, the country may become known for its world-class entrepreneurs.

Dr. Mwangi, CEO and Managing Director of Kenya's Equity Bank Limited, was named the Ernst & Young World Entrepreneur Of The Year® 2012, on 9 June at a gala awards ceremony held in Monte Carlo and webcast live around the world.

Equity Bank is the largest bank by customer base in East and Central Africa and the largest African majority-owned company in the region. The bank has more than 7 million accounts, representing over half of all bank accounts in Kenya. It also has operations in Uganda, South Sudan, Rwanda and Tanzania.

"I'm honored to accept this award on behalf of the people and customers of Equity Bank," Dr. Mwangi said. "This is a global recognition for Africans who are embracing the power of entrepreneurship to change the economic and social state of Africa."

### Transforming lives

Dr. Mwangi played a key role in transforming Equity Bank from a failing micro-finance institution to a publicly listed commercial bank. He has also driven the bank's goal to transform the lives of people socially and economically by giving them access to modern, inclusive financial services.

He spearheaded the bank's investment in an IT platform that can accommodate 35 million accounts, as well as a level-four data center – the only one of its kind in Sub-Saharan Africa – which gave Equity Bank the lead in creating synergy between banking and mobile phones. Additionally, through strategic capitalization, Equity Bank attracted the single largest capital injection in East and Central African history: \$180 million from Helios EB.

#### For entrepreneurs by entrepreneurs

An independent judging panel comprised of distinguished former Entrepreneur Of The Year winners from around the globe selected Dr. Mwangi from among finalists from 51 countries, each of whom had already been named an Ernst & Young Entrepreneur Of The Year in their home country.

# Got jobs?

CNBC called it "fascinating" when they sat down to talk to us in Monaco. But we had a hunch all along that our job creation survey would find that entrepreneurs are creating jobs – no matter where in the world they are. These go-getters give us many gifts – our favorite phones, fun air travel, great daily coffee – but what we really appreciate them for is their ability to create jobs. This is especially important as the world struggles to work its way out of a disheartening economic downturn.

We learned:

- Entrepreneurs expanded jobs overall at a rate of 16% in 2011. Impressive country counts: US at 18%; Australia 18%; Canada 16%; UK 10%.
- More than three-fourths (76%) increased headcount in 2011.
- Entrepreneurs will keep growing in 2012: 68% intend to add to their workforce in their headquarters country - 44% expect to expand outside.
- Only 14% say they hire abroad to take advantage of lower labor costs. The real reason: expansion into a new market. Respondents in Asia (92%), Australia (91%) and the UK (87%) are most likely to hire to capitalize on new global opportunities.




Argentina Marcos Galperin Founder and Chief Executive Officer MercadoLibre

A public company, MercadoLibre hosts the largest online commerce platform in Latin America and provides users with mechanisms for buying and selling goods as well as paying, collecting, generating leads and comparing listings of their products and services. "It's an honor to be awarded for the development of a business model that initiated the democratization of commerce in Latin America and allows over 130,000 people to generate income by selling through our platform," Marcos said.





Austria

Johannes Gutmann Founder and General Manager SONNENTOR

When Johannes Gutmann started SONNENTOR in 1988, he had three organic farmers who supplied herbs for the company. Today, SONNENTOR has more than 120 suppliers and exports to 40 countries worldwide, with tons of herbs and other raw materials. Since its founding, SONNENTOR has had a consistent annual growth of 10% to 20%. The company's products are sold in more than 45 countries - primarily Austria, Germany, Switzerland and the Czech Republic, but also Bali, Japan, Malaysia, Hong Kong, South Korea, New Zealand and others. For Johannes, the starting point for his business was always selling organically farmed goods, based on the concept of supporting small rural structures. The judges described him as a pioneer in fair trade entrepreneurship. Johannes said, "Being a member of the community of Ernst & Young Entrepreneur Of The Year companies is an enormous personal honor and a sign of distinction for our company and our values."



Belgium

Vic Swerts Chairman of the Board Soudal





Soudal has been a Belgium family business for more than 45 years and is still under the direction of its founder and owner, Vic Swerts. From a one-man company, Soudal evolved toward a regional producer of silicones and quickly grew into an international export company of innovative chemical construction specialties. Under the operational guidance of Dirk Coorevits, Soudal now employs 1,453 people; owns eight production plants across Europe, Asia and North and South America; and sells its products in more than 110 countries through 37 of its own affiliates. Innovation is a pillar of Soudal's success, driving the development of 300 new products a year and decades of sustainable, profitable growth.



Brazil Francisco Deusmar de Queirós Founder and Chief Executive Officer

Pague Menos

In 1981, Francisco Deusmar de Queirós opened his first drugstore, Pague Menos, in Fortaleza, the capital of Ceara state in Brazil. Today, with more than 500 stores and 15,000 employees, Pague Menos is a nationally recognized brand throughout Brazil. Deusmar pioneered the concept of "drugstore" in Brazil, and Pague Menos stands out as a model for innovation. Pague Menos' greatest innovation was in 1989 when it began to offer the service of bill payments for water, electricity, telephone and other bills. This increased customer visits to stores and brought convenience to millions who were otherwise hampered by poor public transportation and overcrowding in banks. A few years later, the Central Bank of Brazil recognized the importance of this service, replicating the corresponding banking model, now copied throughout Brazil and other countries.



Canada Dani Reiss President and Chief Executive Officer Canada Goose Inc.

In 1997, Dani Reiss joined Canada Goose, the company his grandfather founded in 1957. At the time, Canada Goose was struggling, due to significant price decreases in the outerwear market as competitors had fled to Asia to take advantage of cheaper labor costs. But Dani has always been committed to keeping the family business in Canada. And since assuming the company's leadership in 2001, he has differentiated Canada Goose by maintaining the highest standards in materials and manufacturing. The company has since grown by 2,500% and is a global leader in premium outerwear. "We pride ourselves on being an internationally respected Canadian brand," Dani said. Dani extends his warmth through social and environmental initiatives. He established three Canada Goose Resource Centres in Canada's High Arctic that provide access to free materials to aboriginal communities for use in their handmade clothing. He also serves as Chairman of Polar Bears International USA.

China-Mainland Ren Yuanlin Chairman Yangzijiang Shipbuilding Group Limited

Ren Yuanlin began as a worker in a state-owned shipbuilding yard. Today, he is a shipping magnate and the chairman of Yangzijiang Shipbuilding Group Limited. By focusing on his goal to develop the best shipbuilding company in China, Ren has led Yangzijiang to become the first private Chinese company listed in Singapore, where it ranked at the top of all Chinese companies listed. In 2010, Yangzijiang became the first mainland company to successfully list in Taiwan. Ren said his Entrepreneur Of The Year Award "is not only recognition of Yangzijiang Shipbuilding, but also an inspiration to the shipbuilding industry in China. Chinese shipbuilders will work together towards the goal of making China one of the world's leading shipbuilders." Ren is also an avid supporter of charity, donating RMB10 million to build schools following the Wenchuan earthquake and overseeing much of the work himself. He has also personally financed new schools in Kazakhstan.

Colombia Yonatan Bursztyn Founder and President Nalsani S.A.

Since he was a young man, Yonatan Bursztyn wanted to have his own company. At age 28 he bought his first manufacturing enterprise. Traveling around the world, he learned about innovative materials and product development, and he realized that creating a global brand was critical to the success of his company. The brand – Totto – opened its first store in 1989. In 1990, Yonatan launched a sportswear line and began expanding to become a global firm. Today, with national and international stores, Totto directly works with about 10,000 employees. Winning the Entrepreneur Of The Year Award gave Yonatan the opportunity to share his dream with others. He recognized the support of his employees and acknowledged that building a global brand through people and their talent results in the growth and development of a country.



**Czech Republic** 

Jannis Samaras Chairman of the Board of Directors and Chief **Executive Officer** Kofola S.A.

Jannis Samaras was born in Czechoslovakia to Greek parents with an entrepreneurial spirit. He and his father, Kostas, started from nothing, importing fruit from Greece, and later they began producing soft drinks. In 2002, they put up all of their assets and bought a license for what was, at the time, an ailing Czech cola-drink brand - Kofola - that had been associated with communism for 50 years. Though nobody believed they would be successful, today Kofola is one of the biggest soft drink producers in the region, and in the Czech Republic and Slovakia, it beats the two most recognized global soft drink brands in the world. Kofola employs more than 2,000 people in its seven production plants in four markets. Jannis said, "Kofola has become a symbol in Europe for what can be achieved if you do something with love and commitment. A good idea will succeed no matter how large your competitors."



Denmark Henrik Sørensen Chief Executive Officer DESMI A/S

Henrik Sørensen leads DESMI A/S, one of Denmark's oldest companies. A supplier of pump solutions, the company dates back more than 175 years. But with Henrik's ambitious and visionary corporate strategy, DESMI A/S seems like a young entrepreneurial venture that's leveraged the opportunities offered by the global market. Employing more than 500 people worldwide, DESMI A/S exports to more than 100 countries. Henrik points to five factors that have led the company to its current position: hard work, skills, perseverance, timing and luck. When Henrik won his Entrepreneur Of The Year Award in Denmark, he said, "Receiving the award is a great honor and recognition of our business, the way we are running our company and the results we have achieved so far."





Estonia Priit Alamäe Founder and Chairman of the Board AS Webmedia Group

Taavi Kotka Co-founder and Member of the Board AS Webmedia Group

Priit Alamäe and Taavi Kotka built one of the largest software and system integration companies in the Baltic States. Founded in Estonia in 2000, the company has grown over 80% each year, making it one of the fastestgrowing technology companies in the Europe, Middle East and Africa region. Priit and Taavi believe success requires passion and hard work. They also feel that in their sector, being young and a little crazy helps. "Because we are young, we have to find new solutions and angles. Entrepreneurs must have the courage to do things in their own new way: stagnation and complacency are waiting for the moment when growth stops."



Finland Mikael Hed Chief Executive Officer Rovio Entertainment Ltd.

Rovio Entertainment was founded in 2003 after Mikael Hed's cousin Niklas Hed, along with his friends, won an innovation competition with a mobile game application. In the beginning, the company went through difficult times, having to dramatically reduce the number of employees. But in 2009, Mikael started carefully analyzing the qualities and user experiences of the most successful games. His research paid off when Rovio rose to global fame with its Angry Birds game. In the past two years, Angry Birds has been downloaded more than 750 million times, making it one of the most downloaded games ever. On winning the Entrepreneur Of The Year Award, Mikael said, "This award is a fantastic recognition for us. Moments like these motivate us to run the extra mile and to expand our vision even further. We hope to inspire other entrepreneurs by showing that great success takes hard work, courage and determination."

**Jean Mane** Chief Executive Officer V Mane Fils

In 1871, Victor Mane started producing fragrant materials from regional flowers and plants. Since then, the small distillery has grown to become one of the leading flavors and fragrances companies worldwide and has continuously been run by the Mane family. Jean Mane joined the family business in 1977, starting as a research chemist. In 1988, he became Technical Director of the Flavor Division and President and CEO in 1995. Jean's vision is intensely focused on growth, innovation and globalization. His leadership has transformed V Mane Fils into an international group having invested in 30 countries and with more than 3,000 employees. He is proud to have made his group the world's sixth-ranked company in its industry. "I am deeply honored and motivated by this award. which recognizes that family corporate governance and entrepreneurship can succeed in times of crisis," Jean said.



Germany Dr. Manfred Wittenstein Chief Executive Officer WITTENSTEIN AG

When Dr. Manfred Wittenstein took over the company that would become WITTENSTEIN AG, he knew he had to make internal changes to save the business and its 50 employees. It was 1979, and he was 30 years old. His father had founded the business - formerly called Dewitta - in 1949, and when Manfred assumed control, it was a manufacturing company for sewing machines for women's gloves. "Drive technology was a growing market," Manfred said. "Our company hit it off: the growth rate rose up to 50% over the next few years. I like to seize opportunities and try to make the best of it." The first sub-company was established in 1984, and today there are 60, operating in 40 countries with 1,400 employees. WITTENSTEIN AG is committed to being a world-class global partner for the customers of its intelligent mechatronic drive technology, servo systems and components.



Greece Spyros Theodoropoulos Chief Executive Officer Chipita S.A.

Spyros Theodoropoulos already was an experienced entrepreneur when he bought a small company in Athens in 1986. Within the first few years of ownership, Spyros had introduced several new products in the sweet-and-savory snacks category. The CEO has defied challenges and transformed Chipita S.A. into an innovation-driven global player with a vision of holding a leading position in all the countries in which it operates. Today, the company has production facilities in 10 countries and employs 9,000 people. It also has forged strong strategic partnerships in Egypt, Saudi Arabia, Mexico and Nigeria - and Turkey is next. Spyros said the Entrepreneur Of The Year Award proves one can achieve distinction without violating one's principles. "More importantly," he adds, "the award is recognition for a Greek businessman in this negative economic environment, demonstrating that Greek entrepreneurship is a source of hope for our country."



Hungary Csaba Soós President E-Star Alternative Plc.

Years of experience, consumer demand and the recognition of an opportunity have all helped Csaba Soós make E-Star Alternative Plc. one of the most dynamically growing companies in the energy sector. Founded in 2000 as an alternative energy supplier, E-Star upgrades and operates the outdated heating and remote heating systems of country towns, institutions and industrial consumers. Today, the company is a leading participant in the ESCO (energy saving company) market for implementing energyefficiency projects in Hungary. Csaba is working to attain a similar market position in Romania, where the company is already counted among the top three companies in its field on the basis of its ongoing projects. "I thank those who thought of me as a nominee for this highly prestigious award," Soós said of the recognition. "Obviously, one does not work to earn recognition like this. One of the group's main business arms, Bank Mayapada, is now the fourth-largest privately owned bank in Indonesia with 150 branches across the country. To diversify his business, Tahir partnered with Duty Free Shoppers USA and eventually became the largest duty-free shop operator in Indonesia. The group also owns several office towers and a hotel. He has acquired one hospital and is working with Singapore to build a hospital in Indonesia. With 500 rooms, it will be Indonesia's largest hospital. Future plans include entering the natural resources sector in coal and nickel and expanding his media empire. Already the owner of Forbes Indonesia and the largest Chinese-language newspaper in Indonesia, Tahir's next big move will be the launch of the Topas TV channel.

In 2005, Shai Agassi was inspired by a profound question posed at the World Economic Forum: "how do you make the world a better place by 2020?" Italy Alessandro Benetton Chairman Benetton Group S.p.A.

When relatives asked him to chart the future of Benetton Group in 2004, Alessandro Benetton accepted with great passion and enthusiasm. He pursued a business strategy based on growth and first-class corporate governance for one of the most recognized international fashion companies in the world. Alessandro's passion is far-reaching and goes beyond the family business. A forerunner in the introduction of the private equity business in Italy, Alessandro founded 21 Investimenti in 1992, of which he is President and Managing Director. Today, 21 Investimenti represents a system of private equity funds with a combined worth of more than €1.2 billion. "I am deeply gratified to have received this recognition for having completed the managerial evolution of Benetton Group, to which I have dedicated, and continue to dedicate, most of my energies," Alessandro said. "It gives me particular pleasure that my role as an entrepreneur was also remembered in my activity in 21 Investimenti."

Akira Yamamura President Ferrotec Corporation

"Our goal when Ferrotec was founded 30 years ago was to turn it into a billion-dollar company - one which was achieved in a short time," Akira Yamamura said. "As the next step, our target is to become a 300 billion yen company." With that as a goal, Akira steers Ferrotec Corporation, a world-leading manufacturer of advanced materials and components and provider of assembly solutions used in a broad array of end products, manufacturing systems and industries. Akira has been praised for his methodical dynamism, international mindset, enthusiasm, acute awareness and innovative creativity. He is well known in the semiconductor industry not only as President of Ferrotec, but as a board member of SEMI for several years. Takeo Shiina, Chairman of the Japan Entrepreneur Of The Year 2011 judging panel, said, "I can see a bright future ahead for this country even in the face of the terrible difficulty we have been experiencing since 11 March 2011. Mr. Yamamura's Ferrotec shines among other entrepreneurial companies."



Jordan Randa Ayoubi Chief Executive Officer Rubicon Group Holding (RGH)



Kenya

Dr. James Mwangi Chief Executive Officer and Managing Director Equity Bank Limited

When Randa Ayoubi raised the financing to form Rubicon Group Holding (RGH) in 2004, digital media production was not an industry in Jordan. Universities and colleges didn't offer training in the technology, but Randa believed in education. She rented most of the internet cafes in Amman and ran newspaper ads offering free classes in animation and digital production. Nearly 500 people took the course, and she selected 36 for additional training. They formed the nucleus team of Rubicon, a global entertainment powerhouse with animation studios in Amman, Los Angeles and Manila and an office in Dubai. Today RGH has 573 more employees than when it began. The company offers games, applications, web content, social media, digital distribution and brand licensing. RGH has productions airing on Cartoon Network, is producing feature films for global distribution and has a themed entertainment division working on a US\$1.5 billion entertainment and leisure resort in Jordan. Similar projects are planned for Australia and China.

Dr. James Mwangi's journey at Equity Bank started in 1993 when the Governor of the Central Bank of Kenya obtained a damning report ranking Equity 66th out of 66 banks. The Governor decided to close the bank to protect depositors, but James left a well-paying job to save the institution. Eighteen years later, he has turned Equity into one of the region's leaders. Its purpose is to transform the lives of Africans by providing modern financial services that maximize their opportunities. With more than 7.3 million accounts, Equity has over 50% of all bank accounts in Kenya, giving it the largest customer base in the region. Through his initiative, the bank also established the Equity Group Foundation, which champions educational initiatives aimed at creating transformational leaders. Equity has focused on the empowerment of youth and women and has spearheaded a successful agricultural campaign. James said, "This award is in recognition of Africans who have continued to believe in themselves and are constantly working to transform their lives."



Korea

Dr. Dae-Gyu Byun Founder, President and Chief Executive Officer HUMAX

It was the Korean venture boom when Dr. Dae-Gyu Byun founded Conin System Co., Ltd., in 1989. The small venture grew into a global leader in the set-top box manufacturing industry. Renamed HUMAX in 1998, the company's revenue exceeded US\$1 billion in 2010, with more than 750 employees worldwide. HUMAX is a leading supplier of high-guality, feature-rich digital TV set-top boxes and digital video recorders for cable, satellite, terrestrial, IPTV and IP-Hybrid broadcasting. The company exports its products to more than 90 countries and is a leading brand in retail markets in the UK, the US, Germany and the Middle East. The company's headquarters and R&D facility are in Korea, with 16 offices worldwide. Dae-Gyu said he believes their story inspires other young entrepreneurs. "In the next 10 years, through new business advancement, we will continue to pursue excellence in innovation," he said. "The Entrepreneur Of The Year Award provides motivation and inspiration to achieve that goal."

With a concession to fly - the first one granted in Mexico in 22 years - but no capital of their own, Volaris founders Pedro Aspe, Roberto Kriete and Enrique Beltranena started raising funds for their new venture. In October 2005, Volaris officially took off as a company and celebrated its maiden flight in March 2006. In just six years, they have grown Volaris to a fleet of 34 airplanes and flown 20 million passengers on 56 routes. It's now the largest low-fare airline in Mexico and the third-largest airline in the country. Offering first-rate customer service, low fares, on-time guarantees and a well-known brand are all differentiating factors that make Volaris stand out. The company is also committed to its corporate social responsibility program, which has helped the company achieve one of the lowest carbon footprints in the air transportation industry.

**Frans van Seumeren** Chief Executive Officer Frans van Seumeren Holdings

It was his father's company when Frans van Seumeren joined Van Seumeren's Crane Company in 1969 at the age of 19. Four years later, he was CEO. During his leadership, the company grew and transformed into a crane-hire company, specializing in heavy lifting and transport projects where engineering plays an important role. The company has been a market leader since 1974. In 2000, the group took over its biggest competitor, Mammoet, and chose Mammoet as its company name. Today, Frans is investing in 15 companies and helping young entrepreneurs follow their dreams. He established the Human Life Foundation, which supports projects in Ghana, such as a school for girls and an amateur football club. "To win the Entrepreneur Of The Year Award is a very big surprise; the reactions of the business world are enormous and warm," Frans said. "It shows also a lot of respect and appreciation for everything I did in my life."



New Zealand Bill Buckley Founder BSL Buckley Systems Ltd

His current enterprise, BSL Buckley Systems Limited, is a success, but business hasn't always been rosy for entrepreneur Bill Buckley. The 1978-launched Buckley Engineering encountered serious glitches, and Bill had to divest majority shareholding to stay afloat. In 1986, he launched Buckley Systems and, in the same year, capitalized on the IT boom in Silicon Valley. He became a major supplier to American factories. Now, Buckley Systems is the global leader in the manufacture and supply of precision electromagnets to 90% of the world's ion implant industry. Everything produced is exported to clients in the US, Britain, Europe, Japan and other Asian destinations. "It's no good doing what anyone can do. You have to go after the stuff that's too complicated for the average engineer so you can be 'Johnny on the spot' when the demand hits," Bill said.



Nigeria Aigboje Aig-Imoukhuede Group Managing Director Access Bank Plc

Aigboje Aig-Imoukhuede's secret to success is never standing still. "I am continuously looking for something new, interesting and something that will add value to our stakeholders," he said. To that end, Access Bank is intent on becoming the catalyst for growth on the African continent. Incorporated in 1989 and listed on the Nigerian Stock Exchange in 1998, the bank serves individual and corporate customers in both the Nigerian and greater African economies. With subsidiaries in eight African countries (covering the three monetary zones on the African continent) and the UK, the Access Bank Group has implanted its brand through its knowledge- and purposedriven philosophy, which demonstrates commitment to the economic and social well-being of the countries in which it does business. On winning the award, Aigboje said, "I am honored to be granted this award, which is not only a reward to my personal achievement, but also and more importantly recognition of the bank's success."



Norway Odd Reitan Chief Executive Officer and Chairman Reitangruppen

The first store of the Reitan family was established in 1948, and Odd Reitan, at age 21, opened his first grocery store in 1972. Today, Reitangruppen is a multinational and multibillion-dollar group. The organization has four business areas and includes Norway's largest grocery chain, Europe's second-largest chain of convenience stores, Norway's fifth-largest privately owned real estate company and a Nordic fuel and energy company. Throughout his 40 years in business, Reitan has been committed to developing Reitangruppen based on a distinct vision and set of values. In fact, the company's eight value principles are carved in stone at several company offices all over Scandinavia, Reitangruppen now has more than 30,000 employees and 3,200 stores and kiosks in seven countries in the Nordics and the Baltics. "I see this award as a great recognition for our 30,000 employees, the entire retail industry in Norway and our many years of commitment to value-based management."

Philippines

**Erramon I. Aboitiz** President and Chief Executive Officer AboitizPower Corporation

Dr. Mohammed Al Barwani started out with a fundamental need to solve problems and create industry standards. Today, he has a range of successes across oilfield services, exploration and production, engineering and manufacturing, and mining. When he left a comfortable job at the Petroleum Development Oman (PDO), Mohammed's entrepreneurial zeal led him to his biggest venture - his flagship brand MB Petroleum Services. Then, realizing a need to diversify, he began Petrogas E&P, United Engineering Services LLC and Mawarid Mining - the largest mining company in the Sultanate. The group has operations in 20 countries, has 6,800 employees and generates revenues in excess of US\$1.2 billion. "It is an honor to be nominated among such stalwarts who have made a positive contribution to the society," Mohammed said. "If my nomination encourages young entrepreneurs to strive for excellence and if I can help them in any way, then I have made a contribution to the society."

Erramon Aboitiz ushered in AboitizPower Corporation's era of growth in 2007 after the company was listed on the Philippine Stock Exchange. He articulated a strong acquisition strategy by raising capital and debt at the right moment and under the right conditions. His vision was to assemble a portfolio of assets that would allow AboitizPower to convert its distribution business to a generating business and, eventually, become a power seller to end users. AboitizPower was incorporated in 1998, and it has grown from a production capacity of 22MW with 420,000 power distribution customers to a capacity of 2,051MW with 720,000 customers. "What the company has accomplished is not the result of one person's effort or ability, but of the whole team inclusive of the men and women that came before us," Erramon said.



Poland

Krzysztof Pawiński President of the Management Board Maspex

One of the largest food companies in Central and Eastern Europe, Maspex was cofounded by Krzysztof Pawiński in 1990. The group is the leading producer of juices, nectars and soft drinks in Poland, the Czech Republic and Slovakia, and it has a strong position in Hungary, Romania and Bulgaria. Maspex is also a Polish market leader in pasta products and controls a significant portion of the Romanian market. In just over 20 years, the company has completed 14 acquisitions, partly abroad. Maspex exports its products to more than 50 countries around the world, accounting for 35% of its turnover. "Our company's success, and in a sense my position in it, is the result of a collective effort," Krzysztof said. "It's a very nice moment – to be recognized by a global company like Ernst & Young is a dream come true."



Portugal Dionísio Pestana Chairman Group Pestana

The story of Group Pestana began in 1965 when its founder, Manuel Pestana, developed a five-star hotel in Portugal. His son Dionísio joined the business in 1976 at the age of 24, took over the chairmanship and has been responsible for the group's growth. Group Pestana has gone from one hotel to a multinational company owning and managing 96 luxury hotels across 10 countries. As the group expanded internationally, it diversified into seven business divisions: hotels, golf resorts, casinos, vacation clubs, travel, brewery and the International Business Centre of Madeira. Today, it's one of the world's leading international hospitality groups, but Pestana still retains the strong family values and work ethic at the company's core. "It's an honor for me, my company and the 7,000 employees who have contributed to the success of Group Pestana with their determination and hard work," Dionísio said, calling the honor "a strong motivating force to continue to invest in and expand on our hotel brand worldwide."



Qatar Ashraf Abu Issa Chairman and Chief Executive Officer Abu Issa Holding

Ashraf Abu Issa took over the family business when he was 19 years old, after his father passed away. Since then, his entrepreneurial and leadership gualities have established Qatar's key retail empires. Abu Issa Holding started with small retail operations. Today, it has grown to more than 120 stores with 2,000 employees. Working together with his brother Nabil Abu Issa, Ashraf has been a pioneer in the Middle East, setting new trends by creating his own retail concept stores: Blue Salon, Highland, Momento, Karisma, Mosafer and Arabesque. Using his market knowledge and strong contacts, Ashraf Abu Issa also diversified the group activities by partnering and offering consultation to large multinationals seeking business in Qatar in the areas of energy, infrastructure, construction, utilities and event management. "Winning the Qatari Entrepreneur Of The Year Award is a responsibility towards my colleagues, my community and above all, my country," Ashraf said.

After joining Eu Yan Sang International Ltd. in 1989, Richard Eu led the transformation of a company best known for its strong roots in traditional Chinese medicine (TCM) into an industry leader by offering a modern scientific approach to TCM health care and wellness products. As head of the listed company, which began as a family business in 1879, Richard capitalized on opportunities for TCM in the growing integrative health care and wellness markets. He broadened the appeal of TCM by launching more convenient and easy-to-use products in modern and accessible retail outlets. His innovative approach soon resulted in Eu Yan Sang brand products being distributed in supermarkets, pharmacies, health food stores and online. "I've learned that entrepreneurship is a journey," Richard said. "It is about the ride, not so much the destination. It is also about self-discovery."

A former physician, Ľuboš Fellner started BUBO Travel Agency, s.r.o., in 1993 with nothing more than an idea and an old bus. Today, BUBO Travel is a leader in exotic trips to more than 150 countries, including Antarctica. In Slovakia, it is the biggest seller of travel to more than 60 countries - China, India, Indonesia, Thailand, Iran, the US, Cuba, Mexico, Kenya, Namibia, New Zealand and Tahiti, to name a few. And by making the most of new and innovative technologies, the agency is now a top seller of flights for numerous international airlines and has plans for further expansion abroad. "This success means a great deal to me," Luboš said. "Straight after the fall of totalitarianism in 1989, we had to forget the boundaries and get beyond them. I was there at the moment when the barbed wire was cut, and I have kept a piece of that wire even today. But Braam and his team worked tirelessly to grow their portfolio, and by 2008 there were 100 Tekkie Towns in Mossel Bay. Now, under the leadership of Doan, Hoang Anh Gia Lai Group has become one of the biggest local multidisciplinary groups in Vietnam with approximately 10,000 employees.
